

PRIVACY POLICY

At ARKONA, we provide services based on trust - our Clients can be sure that their data is processed in a safe way.

The administrator of your personal data is ARKONA Laboratorium Farmakologii Stomatologicznej Grzegorz Kalbarczyk (hereinafter referred to as ARKONA) with its seat in Nasutów 99C, 21-025 Niemce. Your personal data will be processed for the promotion and marketing of services offered by ARKONA, including sending messages by electronic means (SMS, e-mail) containing commercial and service offers from ARKONA.

If you contact ARKONA, you consent to the processing of your personal data. If you participate in any events organised by ARKONA, you consent to the use, recording, processing and reproduction of photos and/or audiovisual materials, via any medium, solely for the purpose of information and promotion, without the need to approve this consent each time. Providing personal data and consenting to the use of the image is voluntary, but necessary to achieve the above-mentioned purposes.

The headquarters of ARKONA is a monitored facility. While staying at our headquarters, you consent to the recording of the image collected using industrial cameras solely for the purpose of protecting the company's property. These data will be stored for a period not longer than 90 days from the date of recording. A person registered by the system has the right to access their personal data and limit the processing of that data. The person registered by the monitoring system has the right to lodge a complaint with the supervisory authority.

Your data will be processed in accordance with the requirements of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data, the Act of 29 August 1997 (Journal of Laws 2016, , item 922) and the Act of May 10, 2018 on the Protection of Personal Data (Journal of Laws 2018, item 1000), as amended.

You have the right, at any time, to obtain information about the content of the data being processed and the right to correct and delete them, as well as to object to their processing, provided that it is compliant with applicable law, by contacting the Personal Data Administrator (hereinafter referred to as Administrator) in electronic form to the e-mail address: info@arkonalfs.com or in writing by letter to the postal address: Nasutów 99 C, 21-025 Niemce.

ARKONA will not store your personal data longer than it is necessary to achieve the purposes for which the data was collected or longer than required by law. Your personal data will be kept on the basis of the consent granted for no longer than 5 years or another period specified by law or until you withdraw your consent. Your data will not be transferred to third parties, with the exception of entities related to ARKONA through capital or personally.

You have the right to access your data and the right to request rectification, deletion or limitation of their processing. At your request, Administrator will provide you with a copy of the personal data subject to processing, and for any subsequent copies, Administrator may charge a fee in the amount resulting from administrative costs.

You have the right to withdraw your consent. Withdrawal of consent does not deprive Administrator of the right to process the data by Administrator, which was collected on the basis of the previously expressed consent. The deletion of your personal data will take place without undue delay, within a technically and logistically justified time, no later than 14 days from receipt of the written notification. You also have the right to transfer your personal data to another Administrator, as long as it is technically possible. In addition, you have the right to lodge a complaint with the supervisory body dealing with the protection of personal data.
